**SECTION B: Terms and Agreement**

- 1. By direction of the landowner, the tenant shall have the responsibility for payment of all charges related to water and sewer service at this parcel, including costs for service calls.
- 2. Property owners will be notified if tenant's account becomes delinquent, or, upon request of owner, of account status.
- 3. **Non-Liability of District:** The District is not and will not be liable for any loss, damage, or inconvenience to any person by reason of shortage, insufficiency, suspension, discontinuance, increase or decrease of water pressure.
- 4. **Non-Liability of District for Sewer Backups:** In areas where there is a potential for sewage backing into the owner's building or premises from the community sewer system, the owner is required to install a backflow prevention device at the point of connection to the system. The Tuolumne Utilities District will not be responsible for damages caused by sewage backups on the above premises.
- 5. **Service Interruption:** The District reserves the right at any and all times to shut off water delivery for the purpose of maintenance, repairs or alterations to the system.
- 6. **Deposit:** A \$80.00 deposit for water service and a \$60.00 deposit for sewer service is required (**Cash or check only**).
